The Events and Tours Program gives us an opportunity to visit music festivals and tours, college events, places of worship, and community gatherings and provides TWLOHA with an opportunity to meet people face-to-face. Going where people are gives us an opportunity to be there to celebrate someone's recovery. We get to be there to hand out local resources to someone looking for help. We get to listen to people tell their stories and share their struggles, and we get to stand in front of them and encourage them to believe in better days. These are conversations that spark change and challenge the stigma that says you can't talk about these issues (depression, addiction, self-injury, and suicide). Each year, we also look forward to celebrating our annual flagship event.

Under this umbrella, we have the opportunity to connect people to places of help via local resources, offer financial assistance that allows someone to sit with a counselor for the first time, and provide grants to organizations that are working in the mental health field.

Every year TWLOHA engages in vital conversations about mental health and suicide prevention on World Suicide Prevention Day (WSPD) and during National Suicide Prevention Week (NSPW). All contributions raised during this annual campaign are invested directly into treatment and recovery.
