We believe the work we do through our website, social media platforms, video and design projects, and interview opportunities gives us a chance to challenge the stigma that surrounds mental health. If the original TWLOHA story proved anything, it was that stories could help people feel less alone. We hope the stories we share will be a reminder that you matter.

The Events and Tours Program gives us an opportunity to visit music festivals and tours, college events, places of worship, and community gatherings and provides TWLOHA with an opportunity to meet people face-to-face. Going where people are gives us an opportunity to be there to celebrate someone's recovery. We get to be there to hand out local resources to someone looking for help. We get to listen to people tell their stories and share their struggles, and we get to stand in front of them and encourage them to believe in better days. These are conversations that spark change and challenge the stigma that says you can't talk about these issues (depression, addiction, self-injury, and suicide). Each year, we also look forward to celebrating our annual flagship event.

Supporter Engagement - TWLOHA would not exist without the support of our volunteer community. We have a variety of activities that volunteers can engage in to help us achieve our mission. Our Intern Program offers three internship terms in which we invite individuals from around the world to join us in Melbourne, FL. Interns receive our MOVE training and professional development skills. The interns live in a community setting and help our staff in all areas of operations. Interns are invited to join us in learning how to live lives that are open and honest and to live in the community while working passionately to present hope and help to those struggling with depression, addiction, self-injury and suicide.
